

**TERMS AND CONDITIONS**

The Director, Maharashtra Fire Services & Fire Adviser to Government of Maharashtra intends to purchase Breathing Apparatus Compressor with self contained Breathing Apparatus set and spare cylinder with D.S.U. for the use of fire service with **EN 137** certificate and **CE** marked and other Fire Fighting Equipments. Tender Notice bearing No. 32/MFS, dated 13.01.2011 has been published in State Government Gazette dated 21<sup>st</sup> January,2011 for calling sealed tenders, so as to reach this office by 4<sup>th</sup> February,2011 up-to 3.00 p.m. If possible, the tenders will be opened on same day at 4.00 p.m.

01. The envelop containing quotation should be **superscripted as Quotation for Fire Fighting & Other Equipment' with its due date** and should be sent in the name of the **Director Maharashtra Fire Services & Fire Adviser to the Government of Maharashtra**. The rates offered should be written both in figures and words and in case there is any difference in the rates, the rates quoted lowest only will be considered as tendered rates.

02. The Tenderer will be have to pay an Earnest Money Deposit of 3% of the total cost of Tender Value or Rs.5,000/- whichever is higher by, Demand Draft Drawn in the name of "**Fire Adviser to the Government of Maharashtra, Mumbai,**" along with the Tender. The amount of Earnest Money deposit will not bear any interest.

03. The earnest money Deposit (EMD) will be liable to be forfeited in the event of Tender being accepted and the Tenderer, refused to execute the order. The rate quoted shall be firmed and valid for a period of 4 months from the date of opening the sealed tenders. The rates quoted should be inclusive of all taxes and transportation charges if any. Octroi is not applicable against Octroi Exemption Certificate. The offer will remain valid for 90 days from the date of opening the tenders.

04. The Tenderer shall supply of the Fire Fighting Equipments within 21 days, from the date of receipt of supply order. The material will have to be issued **on credit**. The Tenderer should supply the equipment as per specification given in tender notice. The Equipments will be accepted after satisfactory inspection report.

05. The blank tender form will be issued at the cost of Rs.500/- from this office up to 31<sup>st</sup> January,2011 during office hours on all working days. The Tenderer should attach a copy of terms and conditions duly accepted along with the tender.

06. The Director, Maharashtra Fire Services & Fire Adviser to the Government of Maharashtra reserves the rights to accept or reject any Tender or all the Tenders without assigning any reason therefore.
